A Memorandum of Understanding has been entered into between the Principal of the College and the Bandha Samaj, registered NGO, for the purpose of providing medical services to the students of the college. The MOU was signed on 22nd day of June, 2023. The parties agreed to abide by the terms and conditions stated below and which the college and the NGO will work together.

1. The NGO will assist the college students in conducting welfare activities as and when necessary.
2. The NGO will assist the college students in conducting community development activities as and when necessary.
3. Different cell and wings of the college such as Internal Complaints Committee, 'Saheli', the Women's Cell, NSS etc. accompanied by faculty members will participate in the welfare programmes organized by the NGO as well as by the college.
4. Programmes to be undertaken by both parties will always be need-based. Such programmes chalked out by the both parties, and will be finalized only after consultation with both party's representatives.

A written approval from Principal will be forwarded to the NGO after which the college students would join the programme, which will be organized by the NGO.

5. Community welfare programmes of the following nature will be organized by the both parties:

- (i) **Health Check Up & Medical Camp** : To be conducted by the college with the help of a qualified Medical Practitioner.
- (ii) **Health Awareness Programmes among Women:** To be conducted in college adjoining village.
- (iii) **Legal Awareness Programmes** : To be conducted among college students and the students and people belonging to college adjoining schools & villages.
- (iv) **Gender Sensitization:** To be conducted various gender sensitization programmes among college students as well as the students and people of college surrounding schools and villages.
- (v) **Environmental Sensitization:** College and NGO members will jointly sensitize about environmental issues in the surrounding locality.

**General terms and Conditions:**

1. Duration of MOU: This MOU will be effective from the date of agreement and will have an initial duration of three years. The MOU may be extended with the consent of both the parties.
2. Engagement of department level coordinator: The College will empower an appropriate faculty to coordinate the implementation of activities.
3. Confidentiality: Both the parties will maintain confidentiality about the terms and conditions of the agreement.
4. Termination of MOU: This MOU may be terminated at any time with a 15 day prior notice from either party.
5. Modification: Any alteration/modification to the MOU may be done with mutual consent of both the parties. Involvement of new activities may be done from time to time with mutual consent of both the parties.
