
Teachers of colleges should "Refrain from undertaking any other employment and commitment including private tuition and coaching classes which are likely to interfere with their professional responsibilities."

Dear Sir,

With reference to your letter on the above mentioned subject, dated 14-06-2021, I like to inform you that as per the amendment Notification of RTI of MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (Department of Personnel and Training) (vide No. 2848GI/12-2, dated 31st July, 2012 & G.S.R. 603 (E)) , the fees towards an RTI applicant have to be paid by demand draft or bankers cheque or Indian Postal Order payable to the Accounts Officer of the public authority. But it has been observed from your application that you have paid Court fee stamp of Rs. 10, which not a valid mode of payment.

Therefore, as per the above mentioned amendment your application is rejected.
